Duke Medical Alumni Association Honors Two Distinguished Pediatrics Physicians

Two physicians who have made important contributions to pediatric medicine will receive awards from the Duke Medical Alumni Association during Medical Alumni Weekend on Friday, October 24.

Lawrence J. D'Angelo, MD, MPH, Chief of the Division of Adolescent and Young Adult Medicine at Children's National Medical Center and Professor of Pediatrics, Medicine, Epidemiology, and Prevention and Community Health at the George Washington University School of Medicine and Health Sciences, will receive the Distinguished Alumnus Award. Samuel L. Katz, MD, Wilburt C. Davison Professor and Chairman Emeritus of the Department of Pediatrics at Duke University Medical Center, will be honored with the W.G. Anlyan, MD, Lifetime Achievement Award.

Dr. D'Angelo's work in HIV infection and AIDS in adolescents has gained him national and international recognition. As one of the first clinicians to recognize the possible impact of HIV infection on the country's adolescents, he helped craft the NIH response to the epidemic. In 1992 the NIH recognized his efforts by presenting him with the National Institute of Allergy and Infectious Diseases Special Award.

Dr. D'Angelo has received more than \$25 million in grants to study HIV infection in teenagers and young adults. His current research focuses on adolescent risk behavior, adherence to medication, and the natural history of HIV in teenagers.

Dr. Katz has made legendary contributions to pediatric medicine. His landmark research in the 1960s led to the release of the measles vaccine, which has saved millions of lives worldwide. He also has made significant contributions to key studies of vaccines against polio, rubella, influenza, pertussis, and *Haemophilus influenzae* type b.

Dr. Katz is currently a member of the Board of Trustees of the International Vaccine Institute and the Scientific Advisory Board of the Emory University Vaccine Center. In addition, he is a liaison member of the Advisory Committee on Immunization Practices of the Centers for Disease Control and Prevention.

Jhaveri, Thornburg Elected to Society for Pediatric Research

Two Duke Department of Pediatrics faculty members were recently elected to the Society for Pediatric Research (SPR), an organization whose mission is to encourage a wide range of cutting-edge science that includes basic, translational, clinical, and health services research and reflects diverse pediatric academic disciplines.

Ravi Jhaveri, MD, Assistant Professor of Pediatrics in the Division of Infectious Diseases, and **Courtney Thornburg, MD**, Assistant Professor of Pediatrics in the Division of Hematology-Oncology, were inducted at the Pediatric Academic Societies Annual Meeting, May 2-6 in Honolulu, Hawaii.

"Dr. Jhaveri and Dr. Thornburg are both extremely talented clinician-scientists and are highly deserving of this honor," says Joseph W. St. Geme, MD, Professor of Pediatrics and Chair of the Department of Pediatrics.

Duke Faculty Elected to the American Pediatric Society

Five Duke Department of Pediatrics physicians were recently elected to the American Pediatric Society (APS), one of the nation's oldest and most prestigious academic societies.

Richard Auten, MD, Professor of Pediatrics in the Division of Neonatology; Rose-Mary Boustany, MD, Adjunct Professor in the Department of Pediatrics; Ira Chiefetz, MD, Professor of Pediatrics and Chief of the Division of Critical Care Medicine; Thomas Murphy, MD, Professor of Pediatrics in the Division of Pulmonary and Sleep Medicine; and Judith Voynow, MD, Associate Professor of Pediatrics, Associate Professor in Cell Biology and Chief of the Division of Pulmonary and Sleep Medicine, were inducted at the Pediatric Academic Societies Annual Meeting, May 2-6 in Honolulu, Hawaii.

According to Joseph W. St. Geme, MD, Professor of Pediatrics and Chair of the Department of Pediatrics, election to the APS reflects recognition for a distinguished career in research, patient care, and education dedicated to children. "These faculty have had an important impact on child health and are richly deserving of this recognition," he says.

Snyderman Foundation Fellowship in Pediatric Obesity

The Center for Nutritional Disorders and Obesity in the Duke Department of Pediatrics is pleased to announce the Snyderman Foundation Fellowship in Pediatric Obesity beginning July 2009. This fellowship program will combine clinical and research training in a variety of areas related to the prevention and treatment of childhood obesity. The clinical experience will include patient care in a multidisciplinary obesity treatment program as well as rotations in cardiology, pulmonology, sports medicine, gastroenterology, nutrition, and endocrinology. The research experience will involve graduate level training in clinical investigation (MPH or equivalent degree), a clinical research project, and structured mentoring.

The Snyderman Foundation Fellowship in Pediatric Obesity was established by Ralph Snyderman, MD, former Chancellor and CEO of Duke University, and is new to Duke.
